# An Overview

---

Community Outreach Programme was registered in India in 1977 under the societies registration act. CORP has grown from a single community centre in Dharavi into a network of 20 centres working across multiple slum communities.

At CORP, we believe that self-sufficiency not dependency, is the key to a life of dignity and self-respect. Last year more than 40,000 residents, primarily women and children from Mumbai's slum communities benefitted from at least one of CORP's programmes, either on a one-off or recurring basis. Every year more than 5,000 families benefit from these programmes. We serve over 2000 children of all age groups each year. Children with disabilities are given nutritious meals, health check-ups and counselling along with hearing aids, callipers and wheelchairs to help cope with their disabilities. For women, CORP has developed an extensive network of education and vocational training programmes to equip them with practical tools and training required to be self-sufficient.

CORP runs a programme for senior citizens called "Food Box for Granny," a grocery distribution initiative which started in 2012 and has turned out to be one of our prime projects. Senior citizens living in the slums not only face a life of loneliness and isolation but also lack of nutritious meals and medical support.

Apart from nurturing women and children, CORP also holds a number of programmes designed to meet the need of the entire slum community. For example our counselling centres resolve the disputes of the women who have been victims of domestic violence. More than 500 health, nutrition and awareness programmes were conducted to provide and promote good health, clean environment, good hygiene and safety habits of eating and drinking.

CORP's mission is to educate, nurture, and guide vulnerable children, empower disadvantaged women and to raise the standard of living for poor slum communities.

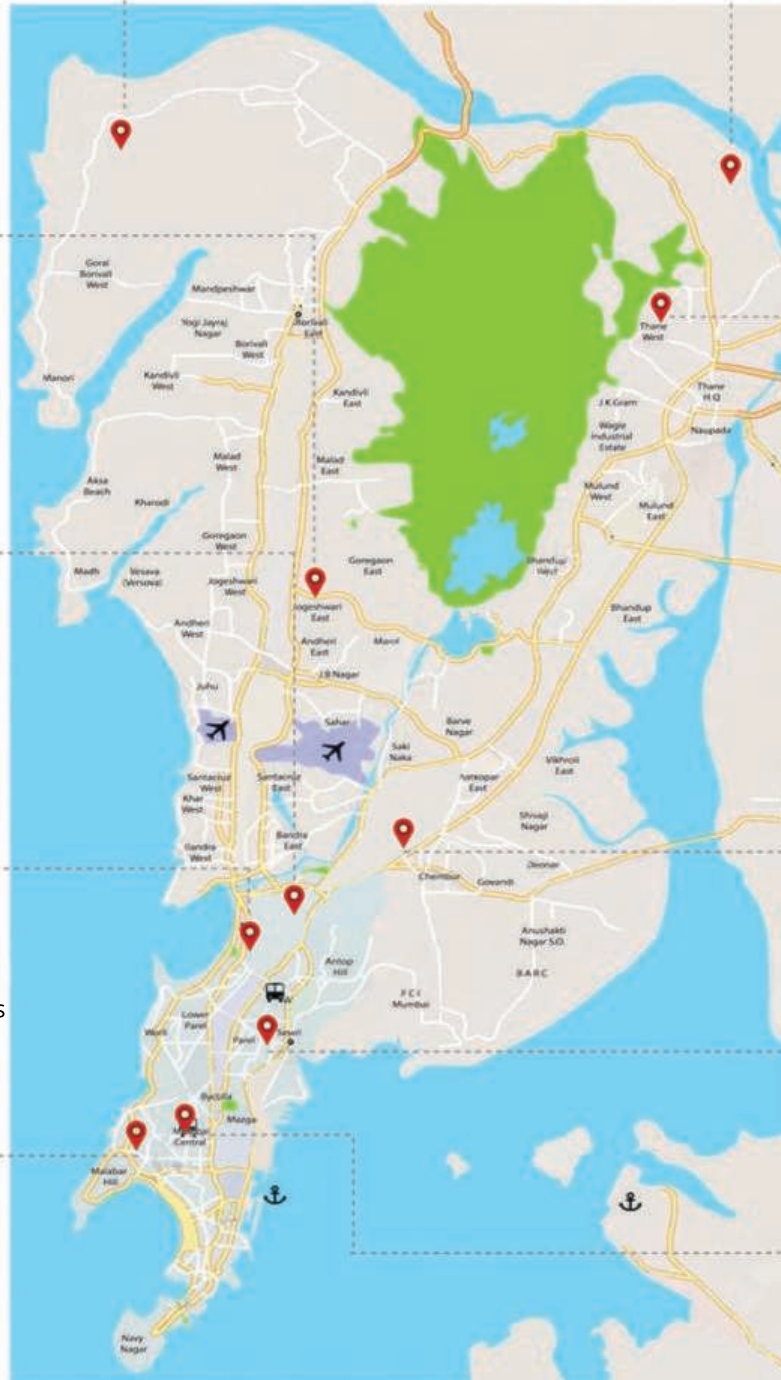

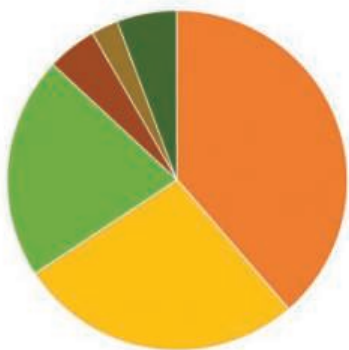


CORP centres are geographically located intended to cover prime areas of Mumbai city. We also have centres on the outskirts of Mumbai like the villages of Virar.



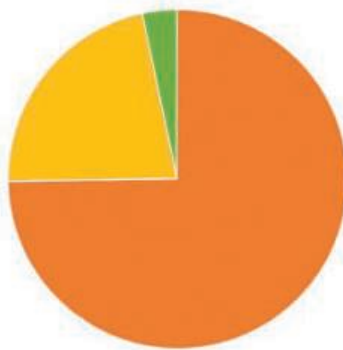

# What We Do





# CHILDREN

## EDUCATION

What will today's children become tomorrow? Will they have pleasant memories to help them be better individuals? Or will they encounter negative experiences which will cause them to become delinquents, and later a burden on society? The circumstances, real-life concerns and needs of the slum children are quite different from those belonging to the middle-class. Extremely crowded, squalid and disorganised living conditions; too little of daily essentials of life; scant parental attention, zeal or encouragement for education; a very low self-image or a level of aspiration and much lower language and intellectual development these are some of the challenging aspects of the life and personality of children from the slum areas.

CORP tries to combat the challenges of life in the slum and help young people achieve their full potential through access to education, emotional support and joyous childhood experience.

## CRECHE AND DAY CARE

Having recognized the crucial role of the early childhood education of children in the development of their future growth, CORP has always been committed to care and educate the young ones.

During such important formative years of the children's lives these crèches prepare them for formal schooling while also providing healthy, nutritious meals, basic healthcare and instruction on basic cleanliness and hygiene. By providing better education CORP is able to enhance the overall standard of living in the slum communities because growing number of women are able to work outside the house knowing that their children are safe and cared for.







## TUITION (TUTORING) CLASSES

Many school children from disadvantaged backgrounds have outside factors that impact their performance in school. These factors include illiterate parents who are incapable of helping them in their studies, small houses which result in lack of privacy or a suitable space to concentrate on studies. CORP provides support to these children through after-school tuition (tutoring) programmes to help them succeed in their studies. This year more than 500 school-going children have benefited from our tuition classes.







## TOY LIBRARY

Toys allow children to use their creativity while developing their imagination, dexterity, physical, cognitive and emotional strength. It is through toys that children at a very early age engage and interact with the world around them. CORP has a Community Toy Library at 12 centres for 700 children from poor slum communities, which is supported by our partner NGO ToyBank.

## CAREER GUIDANCE

CORP conducts career guidance training for underprivileged students who have recently appeared for their Std. 10 and Std. 12 exams. The workshops are conducted at St. Mary's Villa at Khandala, for 100 students and provides a platform to unleash their potential. This training provides awareness on various career options, assists students with gaining confidence to face the outside world and continue their higher education. In the past with the help of CORP's training, hundreds of students continued their studies in universities.





# STREET CHILDREN

---

Our daycare centre for street children in Grant Road aims at rehabilitating homeless children from nearby pathways, railway platforms, streets, traffic signals and bus stands. These children are not safe on the streets, where their chances to grow up innocently is at risk because of the involvement in begging, drug addiction, sexual and physical abuses.

Every day, our staff picks up previously identified children from the streets and brings them to the centre, where they are given a precious alternative. Nearly 80 children are currently enrolled in the programme. The kids attend the centre between 9 am to 6 pm daily, and every aspect of their personal hygiene, healthcare, diet, emotional and psychological issues and education is taken care of. They are sent to the municipal school where they learn basic Hindi, English, Maths, etc. alongside with recreational and sport activities, all in a protected and caring environment.





# SHELTER HOMES

CORP's residential shelters provide children with nutritious meals, quality education, enrollment at private schools, tuitions (tutoring) support, counselling and access to healthcare. It is our aim that these children should complete at least 12<sup>th</sup> grade and enroll at a university or quality non-degree training programme. CORP not only supports university fees but also arranges their stay at the college in dorms/hostels. Also, after completion of their studies, CORP assists the students with job placements.

The first of our shelter home students have graduated from university, acquired gainful employment, and have become self-dependent. They work in graphic design, hotel management, human resources, I.T., accounting, nursing and other professions. Currently, 14 young women and 12 men are working full-time and supporting themselves.







## DIFFERENTLY-ABLED CHILDREN

Children with disabilities in the slum communities face significant hardships. Often, their families cannot meet their needs because they lack resources or education. Children with neurological problems, genetic disorders, like cerebral palsy, Down's syndrome, Autism, ADHS, Epilepsy and Epilepsy syndromes, metabolic disorders, etc. are provided early intervention services.

CORP works with children who have special needs, with the aim of improving lives by maximising independence through education, healthcare and empowerment. Our programmes are focused on two major aspects of checking the drop-outs and inclusion of students in school education.

In addition, the periodic check-up camps and awareness camps are organized. Also, various workshops for students, stakeholders such as teachers, the community people and parents of children with disability are organized with the intent to build sensitivity for differently-abled children.

In addition to these, CORP works in collaboration with institutions providing vocational trainings. Also, skills based trainings, sensitization work-shops, exposure visits, and motivational sessions were organized to create awareness about differently-abled youth.

Children receive nutritious meals and regular medical care including provision of hearing aids and prosthetics. After school hours, children take part in various educational activities and are engaged in tuition classes, computer literacy, counselling, drawing and craft are conducted at our center.

Through this project more than 325 special children are supported and rehabilitated till-date.



## Meet Ram... a success story...



Cerebral Palsy is a condition that makes it hard to move certain parts of the body. It's the most common form of childhood disability. Raising and caring for a child with Cerebral Disability isn't easy.

Ram is 14 years old and was diagnosed with Cerebral Palsy which made him unable to move because of the tightness in both his hands and feet. Ram along with his twin brother lives in a small room in the slums of Dharavi. His father is a vegetable seller and the only breadwinner in the family.

CORP identified Ram during a community visit and enrolled him in the CORP programme for differently-abled children. He went through operations to release his muscle tightness and post-surgery and his situation improved. He has already learned how to use the computer and loves typing. CORP also enrolled him in a special school where he got accepted. Ram has also participated in various marathons and stood first. His parents are very happy to see such major improvements which, allow him to be less of a burden to his family and open up to a brighter future for himself.



## *Meet Lalita... a success story*



I am Lalita, 38 years old and a mother of three children. My husband's family disliked me and hence opposed my marriage. Unfortunately, after my husband's death his family removed me from the household and so I stayed with my kids on the streets and railway stations of Mumbai. I work as a house-maid to cover the family expenses needed for our livelihood and sustenance. A few years ago, I fortunately happened to come to know about CORP. Indeed, this contact was truly a ray of hope for my minor children. CORP started supporting my three kids at the Street Children Project in Grant Road, catering to their educational and healthcare needs. Moreover, CORP arranged sponsorship for two of my children at a reputed English-medium school in Panchgani, where both of them are studying in a residential school. I am proud to say that my eldest son, who is 17 years old, has completed his SSC Board Examination this year, solely due to CORP's support, motivation and encouragement. I am overwhelmed with joy at the achievement in his academics and this amazing change in his life. I am extremely grateful to CORP for providing my children with this unique opportunity to study, which I had never previously expected. I foresee a bright future for all of my children, who will certainly move forward and live life with dignity.



# WOMEN EMPOWERMENT

## VOCATIONAL TRAINING & INCOME GENERATION

CORP believes that women empowerment is imperative for the advancement of a whole community, and this is the reason why we started vocational training and income generation programmes in the underdeveloped areas of Mumbai. This provides them with an alternative to break the traditional roles that see women as housekeepers and non-independent members of the family.

Our community centres provide certified vocational courses with standardized and improved curricula, professional trainers and modern equipment in tailoring, embroidery, jewelry-making, beautician, mehndi and Montessori teachers training. These endow them with new working skills and the necessary self-confidence, and in this way they learn how to seek outside employment and be autonomous.

CORP also provides income generation activities, in which over 200 women annually receive a salary from producing uniforms, bags, customized hand-made accessories and soft toys. The income generation project is supported by our partner organizations, Brembo, CESVI, 2nd Inning Handicraft Pvt Limited, Pashoo-Pakshee, I Was A Sari Project and Chindi project.







### -Women's Day Celebrations-

CORP celebrated International Women's Day 2018, with a gathering of over 1000 women from different slum communities and self-help groups where CORP provides services.

The Chief Guest, Ms. Angela Thurston from Harvard University, USA, graced the programme. Ms. Angela spoke on the theme "Press For Progress" motivating women to collectively strive for their rights, gender parity and justice. She also encouraged to the womenfolk to rely on their inner strength, to tap into the place of light and truth which unites them.







## PREGNANCY CLUB

CORP does not underestimate the importance of proper medical care, adequate information and awareness-building during the course of pregnancy.

Through accurate, regular and interactive meetings and medical check-ups, first-aid, medical investigation, referral for treatment and hospitalization, health awareness camps, regular nutrition and supplements, CORP is able to monitor the growth of the infant and the health condition of the mother.

The outcome of these initiatives is the decrease of infant mortality and increase of safe child birth for women in the community.

The goal of CORP has always been to increase the quality of health services in the community, ensuring that every community member, especially the children and pregnant women, have access to adequate health care, thereby decreasing the rate of maternal deaths and child mortality.





## *Meet Neha... a success story...*



As a kid, I lived on the streets at Grant Road and went through some bad experiences that left me traumatized. I later grew up in CORP's Girls Shelter Home. I attended school but dropped out in 7th grade since learning was challenging for me. I was enrolled in the tailoring class and started learning stitching. Thanks to the support and care of the staff at the tailoring unit, I started working independently after one year. Learning to work and interact with other people helped me feel more confident and secure about myself. During the training period, I also received a small stipend that was directly put into my bank account, so that I could eventually become more independent. Initially, I was employed as a part-time staff and now I am in-charge of the packaging department. I have learned to be highly self-dependent. CORP has really changed my life.



# COMMUNITY

## SUPPORT FOR SENIOR CITIZENS

Elderly people in underprivileged communities have to go through years of difficulties, like loneliness, isolation, deteriorating health and lack of monetary savings. Increasing cost of living, expensive medical services, lack of an adequate financial support: all these factors make the seniors very vulnerable.

CORP is working for disadvantaged senior citizens so that they can live healthy lives with the contributions from the current generation as well as empathy and a helping hand. Needless to say, the generous monetary assistance of our donors has enhanced the life expectancy and well-being of these elderly.

*About 250 destitute senior citizens are being supported with “Food Box for Granny” which consists of a monthly ration and also daily essentials, as well as basic healthcare.*



Laxmi Dattu, 71 years old, a widow, is a daily wage labourer. To earn her livelihood she steps out of Bhoypada Village in Virar and goes to the forest to collect and sell firewood, She does not have a proper house to live in and so stays at her in-laws house.

Laxmi is overwhelmed with joy and says, “My life improved significantly, after I received support from CORP. I was suffering from joints pain and was not able to walk but after treatment, I can now walk. CORP provides monthly ration and also regular healthcare check-up. By God’s grace, I am surviving and living a happy life.”





## FAMILY COUNSELLING CENTRE

(Supported by Central Social Welfare Board, Govt. of India)

CORP's Family Counselling Centre (FCC) works with women and their families providing advice and assistance to solve their disputes. FCC addresses issues of domestic violence, marital maladjustment, dowry harassment, property disputes, neighbourhood disputes, pre-marital relationships etc.

This year, 169 cases were registered, 52 old cases were followed-up and 148 cases were settled by the efforts of our counsellors.

The services provided by our centre assists the community members to seek professional help to solve their problems. Also, free legal advice is offered at the Centre throughout the year.

Thanks to Central Social Welfare Board (CSWB), Government of India and Maharashtra State Social Welfare Board (MSSWB) for the Grant-in-aid, timely support and encouragement.

During the year, our FCC organised **Swachhta Pakhwada 2017** and cleaned our premises, crèche centres, community areas and created awareness about cleanliness, hygiene and sanitation. **Beti Bachao, Beti Padhao** Abhiyan was conducted to encourage the community people to protect, educate and respect the girl child. Also, the **Tree plantation** was organised in different places and several saplings and trees were planted.





## HEALTH AND NUTRITION

The health programme of CORP includes health and nutrition awareness campaigns, which aim to educate the communities on disease prevention and proper nutrition.

CORP conducted awareness programmes related to community health with the help of doctors and their medical teams. These programmes helped improve the knowledge and attitude of patients about detection, treatment and control on diseases. They created public awareness about ill-effects of alcohol, smoking and drugs and promoted good health, encouraged residents to maintain a clean environment and practice hygiene.

'SWACHATA-ABHIYAN' was initiated for imparting awareness on cleanliness and hygiene and conducted in different slums across Mumbai.

**In fact, CORP feeds more than 2,000 children daily.**

Interns taught school syllabus, imparted computer skills and conducted recreational activities to the children at our different projects. This initiative is always mutually beneficial. Thanks to the interns who devoted their valuable time and energy, during the past year interacting with and assisting the children.

College of Social Work, Nirmala Niketan has been placing its students of Bachelor in Social Work (BSW) as well as Masters in Social Work (MSW) courses in Community Outreach Programme (CORP) since last six years for fieldwork. As a faculty supervisor, I am grateful to CORP for it has been an enriching and wonderful experience for me as well as for my students. Field learning plays a leading role in social work education as students need to have opportunities for both theoretical and practical learning. The students placed in CORP have expressed often that though they learnt a lot through classroom learning about social issues and social work interventions, it is the fieldwork experience in CORP that has helped them crystalize these learnings and make them meaningful by translating them into action. Students receive able and nurturing guidance from the director, centre supervisors, social workers as well as rest of the staff. They learn not only about the skills and strategies important for intervention but also develop values required to be a responsible and empathetic social worker, a democratic leader and a dependable team worker. The students learn these values from the models that are present in the organization itself – from the director at the top to the caretaker in the centre - who work as a team towards the vision and mission of the organization. The role and contribution of each one is acknowledged and appreciated, including that of the students. The students are encouraged to take on new initiatives and the support is always available to them to learn and contribute. I really cannot thank CORP enough for giving such inspiring field exposure and facilitative learning environment for my students.

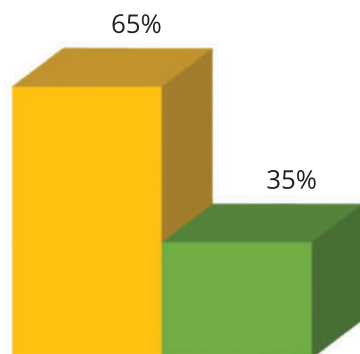

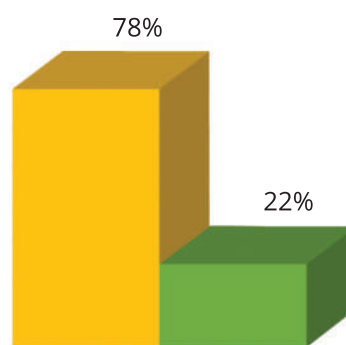

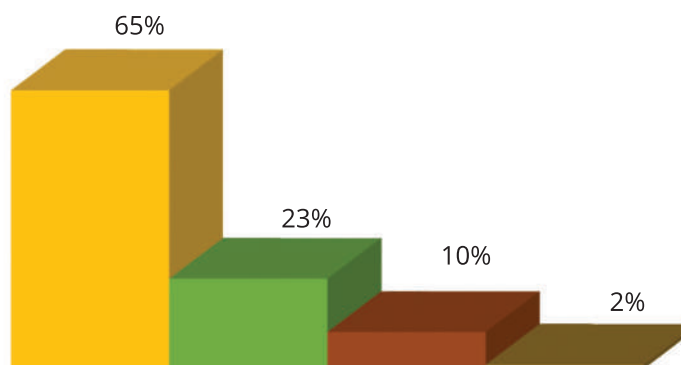

### Nature of Funds



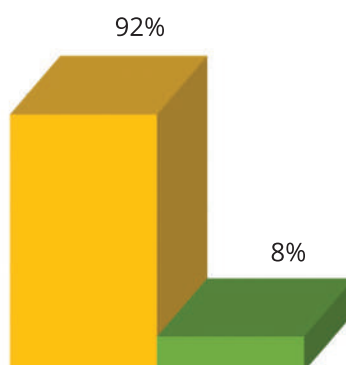
